ADVANCING THE PRO BONO MOVEMENT

At CFP Board, we believe that our certificants have a unique opportunity to extend critical services to underserved and at-risk Americans in need of ethical and objective financial guidance. The Board of Directors recently approved a Resolution encouraging CFP® professionals to participate in pro bono financial planning. In the Resolution, CFP Board recommends that CFP® professionals commit to a minimum of 20 hours per year of pro bono service, and it also encourages firms that employ CFP® professionals to support them in their pro bono activities and efforts.

In recognition of the remarkable dedication of CFP® professionals who provide pro bono services, CFP Board has introduced digital pro bono badges. The digital badges will be awarded to individuals who have completed 20+, 60+, or 100+ hours of pro bono financial planning.

WHAT IS PRO BONO FINANCIAL PLANNING?

CFP Board and FFP define pro bono financial planning as free, no-strings attached financial advice or guidance provided by or in conjunction with a CFP® professional volunteer for people who cannot afford a financial planner. Pro bono services can be delivered through either one-on-one or small group, interactive sessions.

Planners can connect to pro bono opportunities through FFP's volunteer matching platform, **ProBonoPlannerMatch.Org**, or through their local FPA chapter or NAPFA-organized event.

Planners may also identify pro bono volunteer opportunities in their local communities.

Roadmap to Pro Bono Volunteering

1. Attend FFP's Free Training Course

This **FREE one-hour online course** is designed to give financial planners the skills and techniques to address the specific needs of lower-income individuals and families. This training course is approved for one CE credit by CFP Board. Advisors can also view FFP's free skill-building webinars on various pro bono related topics at **ffpprobono.org/webinars**.

2. Register for Pro Bono Planner Match

FFP helps CFP® professionals match with nonprofit organizations seeking pro bono financial planning assistance for their constituents through its national volunteer opportunity clearinghouse, **ProBonoPlannerMatch.Org**. There are many types of pro bono activities listed including virtual and in-person opportunities.

*Planners can also connect to pro bono opportunities through another nonprofit organization; or through their local FPA chapter; or NAPFA-organized effort or on a more informal basis with underserved members of their community.

3. Report your Pro Bono Hours

Log into your **CFP.net account** and report your volunteer hours to CFP Board. Not only can you report hours from this year, but you can report your pro bono hours from the prior two years as well. While you're there, be sure to sign up for the quarterly Pro Bono Newsletter!


